2) **EVALUATOR** - As of March, 2005, after each CGC test, Evaluator should send only the one-page TEST SUMMARY FORM to AKC. Evaluator should now keep yellow copies for 1 year. Owners should be given original (white) copy to send to AKC and 2-sided copy listing test items for their records.
